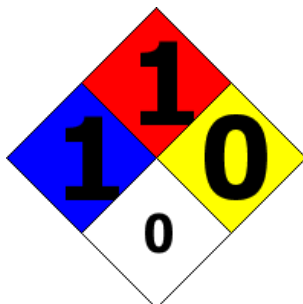

SECTION 4 : First aid measures

Description of first aid measures

SECTION 5 : Firefighting measures

Extinguishing media

Suitable extinguishing agents: If in laboratory setting, follow laboratory fire suppression procedures. Use appropriate fire suppression agents for adjacent combustible materials or sources of ignition

Special hazards arising from the substance or mixture:

Combustion products may include carbon oxides or other toxic vapors. Thermal decomposition can lead to release of irritating gases and vapors. Avoid generating dust; fine dust dispersed in air in sufficient concentrations, and in the presence of an ignition source is a potential dust explosion hazard.

Advice for firefighters:

Protective equipment: Use NIOSH-approved respiratory protection/breathing apparatus.

SECTION 7 : Handling and storage

Precautions for safe handling:

Minimize dust generation and accumulation. Wash hands after handling. Follow good hygiene procedures when handling chemical materials. Do not eat, drink, smoke, or use personal products when handling chemical substances. Use only in well ventilated areas. Avoid contact with eyes, skin, and clothing.

Provide ventilation for containers. Store in cool, dry conditions in well sealed containers. Store with like hazards

Appropriate Engineering controls:
